## Notice Regarding Counterfeit Pioneer Head Units, Dash Cameras and Speakers

We have recently discovered that there are counterfeit head units, dash cameras and speakers bearing the Pioneer brand name for sale to Malaysian consumers in both online marketplaces and physical stores. These counterfeit head units, dash cameras and speakers are inferior in terms of quality whereas customer safety and product quality have always been Pioneer's top priority.

The sale of products that violate the laws including counterfeit goods is strictly prohibited and Pioneer has been working closely with the respective authorities to investigate the sale of such counterfeit products.

In a recent case, a raid action undertaken together with The Ministry of Domestic Trade and Consumer Affairs (KPDN) Sarawak has been conducted in Kuching, Sarawak. A total of 902 units of counterfeit Pioneer products worth RM442,977 have been seized in order to prevent distribution to Malaysian consumers. The seized goods were of Chinese origin and were brought into Malaysia by disreputable importers.
